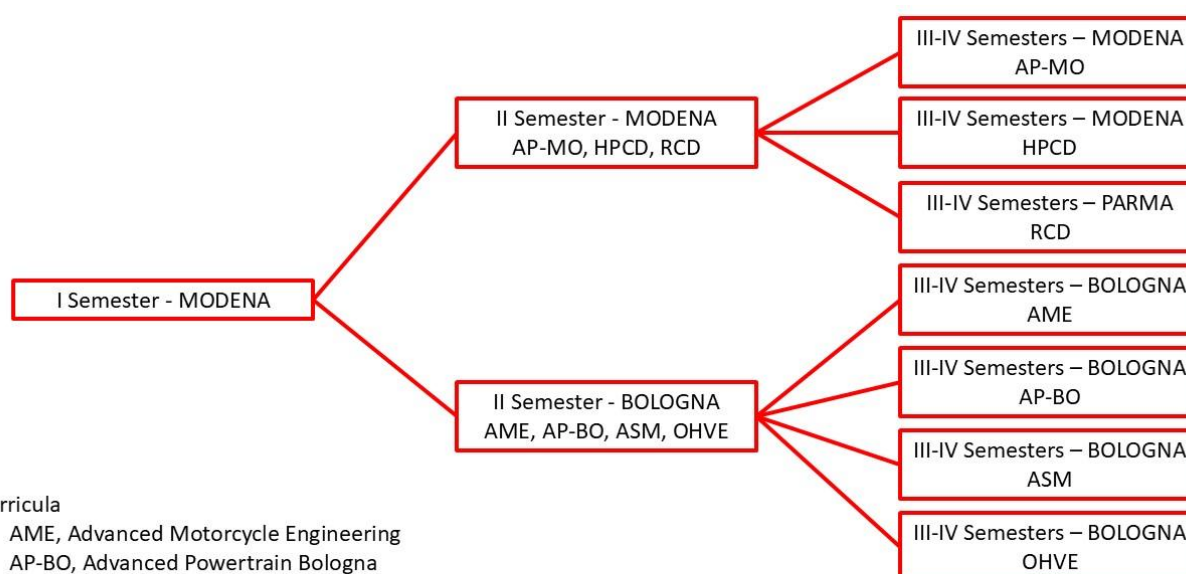
The programme will be held entirely in English

1. SUBJECT

At the University of Modena and Reggio Emilia, from **13/05/2026 to 01/07/2026** candidates can submit their online applications for the admission to the Master's Degree Programme in Advanced Automotive Engineering. The programme includes seven curricula and there are **119 places** available reserved to Italian, European and non-European students who are legally residing in Italy. These places are divided as follows:

- Advanced Motorcycle Engineering – **14 places**;
- Advanced Powertrain- Bologna – **17 places**;
- Advanced Powertrain- Modena – **17 places**;
- Advanced Sportscar Manufacturing – **14 places**;
- High Performance Car Design – **17 places**;
- Off-Highway Vehicle Engineering – **15 places**;
- Racing Car Design – **25 places**;

Depending on the curriculum, teaching activities take place at the teaching sites in Bologna (BO), Modena (MO) and Parma (PR) as shown in Figure 1:

Any places reserved for international students requiring an entry visa for Italy, which should remain vacant, will be made available to Italian, EU and non-EU applicants with regular residence in Italy, in accordance with the deadlines set out in the call for admission to the Master's Degree in Advanced Automotive Engineering reserved for Italian, EU and non-EU students with regular residence in Italy.

In order to guarantee the right to study to the greatest extent possible and in compliance with the procedures outlined in the call for applications, in case of remaining vacant places at the expiry of applications submission deadlines set for 01/07/2026, the University reserves the right to issue a second call for application.

2. QUALIFICATIONS AND KNOWLEDGE REQUIRED FOR THE ADMISSION

Eligibility requirements for the Master's Degree programme are as follows:

A) Previous educational qualification

Admission to the Master's Degree Course is open to: i) students who have already obtained their degree (**graduate students**); ii) students who will graduate by 15 December 2026 (**prospective graduates**). Below are the requirements for the two types of students:

1) Graduate students

Candidates shall possess one of the following study qualifications:

- Bachelor's Degree;
- Three-year University Diploma;
- Five-year University Degree (before MD 509/1999);

obtained with a minimum score of 95/110 or, for study qualifications obtained abroad and considered equivalent, at least 86% of the maximum score or a ranking in the top 30% of the candidate's reference class.

2) Prospective graduates

Candidates shall have obtained at least 138 university credits-CFU (or at least 76% of the ECTS required by the degree programme) by 01/07/2026, deadline for enrolling in the selection, and the qualification required (listed at the previous point) has to be obtained by 15/12/2026 with a minimum score of 95/110 or, for study qualifications obtained abroad and considered equivalent, at least 86% of the maximum score or a ranking in the top 30% of the candidate's reference class.

Those applicants who do not obtain the degree by that date will be excluded by the procedure, even if they are in the admitted list and have already enrolled.

B) Previous knowledge

The knowledge required for accessing this programme refers to a suitable knowledge of general scientific methods and contents in the **basic disciplines** (Mathematics, Computer Science, Statistics, Physics and Chemistry) as well as in **engineering disciplines that are preparatory for the specific subjects of the degree programme**. Three-year degree programmes in Mechanical, Vehicle, Aerospace and Industrial Engineering automatically guarantee the consistency of prior knowledge; other degree programmes will be evaluated by a dedicated Board by examining the candidate's academic career.

For applicants possessing an Italian study qualification, the curriculum requirements to access the programme are a minimum of 85 credits in the scientific disciplinary sectors (SDSs) as shown in Table 1 below, also referring to the minimum requirements set in Table 2

(NOTE: Given the recent renaming of the SSDs, the sectors are reported in both the current and previous formats; the candidate may submit documentation with either the current or previous SSDs name).

C) English language knowledge

Knowledge of the English language at a level suitable to use texts of the sector and to follow the classes and seminars in English, **equivalent at least to level B2 of the common European framework**. The following documents shall be submitted:

- International certificate recognised by UNIMORE, among those listed at the link: <http://www.cla.unimore.it/site/en/home/certifications.html>;
- University examinations on English language skills at a level equivalent to B2, documented by a certificate from the home University;
- Proof that the degree or diploma obtained is awarded in English;
- Proof of origin from English mother-tongue countries (foreign or Italian citizens who are fluent in English as a consequence of their family background or linguistic experience shall be considered native speakers).

Potential students who cannot provide documentation certifying their language proficiency at the time of application may take a B2-level English test remotely through the Language Centre of the University of Modena and Reggio Emilia. Enrolment in the English test is subject to the application for the degree programme of interest. Applicants should therefore submit their application without the English certificate and then register on ESSE3 for the B2 test on one of the available dates. After taking the test, successful candidates will receive a B2 certificate. They must then contact the Student Secretariat to have their application reopened, attach the B2 certificate to the application, save it, and close it again. The entire procedure has to be completed before the deadline of the call for applications.

The fulfilment of the curricular requirements for eligibility to the degree programme is assessed by a specific Board that analyses the documents submitted.

3. SUBMITTING THE APPLICATION

Applications can only be submitted online between **13/05/2026** and **01/07/2026** at 1.00 p.m. (CEST) by accessing the website <http://www.esse3.unimore.it>.

The procedure involves the following steps:

1. Register on the Esse3 website. Enter your personal details, place of birth, residence, domicile, telephone number and e-mail address.
If the registration is successful, a username and password (personal data) will be displayed, which are required for the next steps. The login details will also be sent to the student by e-mail.

2. Enter your username and password to access the personal area in Esse3.
3. In the menu on the right, select “Registered Area / Student Area - Admission” and select “Advanced Automotive Engineering” from the list of degree programmes.

Each candidate may only submit one application, in which it is MANDATORY to indicate the order of preference of the following seven curricula:

- Advanced Motorcycle Engineering
- Advanced Powertrain – Bologna
- Advanced Powertrain – Modena
- Advanced Sportscar Manufacturing
- High Performance Car Design
- Off-Highway Vehicle Engineering
- Racing Car Design

The order of preference indicated in the application is binding and CANNOT be changed later.

Once all the procedures for enrolment in the Degree programme have been completed, enrolled students may submit a request to change the curriculum, following the instructions in the specific notice published at the link:

The requests will be evaluated by the Degree Programme Council.

In the event that the question "Do you want to submit your application now?" has been answered with "Yes", but the attachments have not been submitted correctly or completely via the online procedure, candidates can send an email to segrstud.ingegneria@unimore.it by 01/07/2026 at 1:00 p.m. (CEST), providing a valid ID and explaining the problem. Should it be necessary to re-open the application to amend the attached documents or attach new ones, please note that **it is the applicant's responsibility to finalise and close the application, to avoid exclusion from the evaluation.**

IMPORTANT: the application will not be submitted correctly until you save the data and answer YES in the specific field "Do you want to submit your application now?". Once the submission has been successfully completed, printing of the application will become possible. The Board WILL NOT assess candidates whose application HAS NOT been explicitly confirmed.

The application for admission requires a non-refundable contribution of € 60,00 to cover the costs. Payment shall be made BY 01/07/2026.

4. RANKING

At the end of the evaluation process, a ranking list will be drawn up listing the admitted candidates on the basis of the results of the assessment and taking into account the preferences expressed by the candidates in the application. The ranking list will be published **by 03/08/2026** on the website <https://wss.unimore.it/public/albo> (search for the type: "Calls and Tenders" and the "Students" area)

This will be displayed in the reserved area of the website after logging in with the username and password provided upon registration.

Warning: the ranking list will only be published on the above-mentioned website and NO communications will be sent directly to the applicants.

Should further places become available at the end of the pre-enrolment process (described in section 5), the ranking list will be updated automatically.

The ranking list will be drawn up with a score out of 100 by considering:

- 1. the candidate's previous career;**
- 2. any curricular experience related to participation in student mobility programmes and/or in "Learning by Doing" university projects and/or to carrying out a curricular internship in a field similar to that of the degree programme;**
- 3. the content of the self-presentation video.**

A minimum score of 6/10 in relation to the self-presentation video is required for admission, as specified in Appendix C of this call for applications.

Tie ranking

In the event of tie ranking, the youngest candidate shall take precedence.

Candidates will be included in the ranking of the curriculum for which they have indicated the highest preference among those in which they have obtained a useful ranking, as well as in the rankings of the curricula for which they have not obtained a useful ranking, but for which they have indicated an even higher preference.

Some examples are given below:

Example no. 1: the score ranks the applicant high enough to enroll only in the seventh-choice curriculum: in this case the applicant remains in the rankings of sixth-, fifth-, fourth-, third-, second- and first-choice curricula for any possible future "reassignment", for which please refer to section 6 "Assignment of vacant places".

Example no. 2: the test score ranks the applicant high enough to enroll in the third-choice curriculum: in this case the applicant remains in the rankings of second- and first-choice curricula and is removed from the rankings of the fourth-, fifth-, sixth- and seventh-choice curricula.

5. ENROLMENT OF CANDIDATES USEFULLY LISTED IN THE RANKING

1) STUDENTS WHO HAVE OR MAY HAVE AN ITALIAN STUDY QUALIFICATION

Admitted candidates are entitled to enrol from the date of publication of the ranking list and until **03/09/2026 at 1:00 p.m. (CEST)** by accessing the website www.esse3.unimore.it, clicking on "Enrolment", and following the instructions in the "Online enrolment" guide available on <https://www.unimore.it/en/services/guides-online-procedures>.

Filling out the enrolment application and paying the first fee instalment will result in the enrolment under the condition of being definitive only after the verification carried out by the relevant offices.

In case there is information to be confirmed or clarify, the applicant will be contacted through the email address provided when registering to Esse3 to regulate their situation. If after 15 days from the payment no communication is received, the enrolment is considered definitive. Any mistakes detected in the online enrolment completed by the applicant will be communicated to the email address provided when registering to Esse3.

NOTE: payments made after the enrolment deadline SHALL NOT be valid for enrolment purposes.

Before starting the procedure, make sure you have the following documents in electronic format:

- passport photo;
- double-sided copy of a valid identity card;
- copy of the residence permit (for non-European students who are legally residing in Italy).

The enrolment procedure consists of two steps:

1. **completing the online enrolment procedure:** candidates shall use SPID or the username and password they received when registering, access the Reserved Area of the website and confirm the data entered at the time of submitting their application (www.esse3.unimore.it, select "Enrolment" after logging in).
2. **paying the university enrolment fee for the programme:** the payment is done on the website www.esse3.unimore.it. Click on "Login" and sign into your reserved area. Then click on "Taxes" and follow the instructions to view the amount due and access the PA payment circuit:, as indicated on the website <https://www.unimore.it/en/education/enrolment-and-admission/paying-university-tuition-fees>. Payment of the due amounts must be made exclusively via the **PagoPA** circuit, which allows **online payment** by choosing your Payment Service Provider - **PSP**. Upon payment, an email will be sent to the personal mailbox indicated during registration, or to the University mailbox if it is already activated. From your personal Esse3 page, you can print out the payment receipt under "Taxes". Please note that the amount of commission due may vary depending on the PSP chosen.

Mind the deadlines

Regardless of the justifying reason, payments dated after 03 September 2026 on the payment receipt (RT) is will not be considered valid for enrolment.

Warning! According to the AgID, the Agency for Digital Italy, the payment could be processed by the Payment Service Provider (PSP) the day after the payer's request, which will affect the success of the enrolment.

3. **verification in Esse3 the acquisition of the payment made:** candidates are required to check on their personal Esse3 page, in the "Taxes" section, the acquisition of the payment made. If the payment does not result registered in Esse3 within **2 WORKING DAYS** from the payment date, students must send the payment electronic receipt to the Student Secretariat of the Engineering Department "Enzo Ferrari", at the following e-mail address: segrstud.ingegneria@unimore.it together with a valid identity document.

Candidates entitled to enrolment who do not complete the aforementioned operations within the deadlines will be considered to have withdrawn. Their places will be made available to suitable candidates, according to the order of the ranking.

Candidates who are not in possession of the qualification required for enrolment, as undergraduates, will have to **update the information** on the date and the graduation score **no later than 15/12/2026** by entering their personal page at entry "Qualifications" (except for UNIMORE graduates, for which the information will be automatically uploaded to the system).

2) STUDENTS WHO HAVE OR MAY HAVE A FOREIGN STUDY QUALIFICATION

Admitted candidates are entitled to enrol from the date of publication of the ranking list and until **03/09/2026 at 1:00 p.m. (CEST)**.

- double-sided copy of a valid identity card;
- copy of the residence permit (for non-European students who are legally residing in Italy).

Those already holding the study qualification shall also hand over:

- original degree certificate with translation certified by the Italian embassy/consulate of the country in which the qualification was obtained;
- declaration of value of the degree diploma, issued by the embassy/consulate, alternatively, it is possible to present a certificate issued by the Italian ENIC-NARIC center (CIMEA), or check whether the qualification held is automatically recognized according to ARDI.

The Registrar's Office, after verifying the correctness and completeness of the documents submitted by the student, will issue on Esse3, on the personal page of the student and under the section "Taxes", the tax slips with the expected amount to be paid for the enrolment. This needs to be paid through the circuit pago PA. The Registrar's office will confirm the enrolment once the enrolling student has paid the first fee instalment. Regardless of the justifying reason, payments dated after 03 September 2026 on the payment receipt (RT) is will not be considered valid for enrolment.

Warning! According to the AgID, the Agency for Digital Italy, the payment could be processed by the Payment Service Provider (PSP) the day after the payer's request, which will affect the success of the enrolment.

7. PROCEDURE FOR CURRICULUM CHANGE REQUEST RESERVED FOR STUDENT ENROLLED IN THE 1ST YEAR IN 2025/2026

Requests to change curriculum for places that got available in the second year on the academic year 2026/2027 can be submitted only by students enrolled in the first year of the program in 2025/2026.

Places available:

- Advanced Motorcycle Engineering – **6 places**;
- Advanced Powertrain – Bologna – **9 places**;
- Advanced Powertrain – Modena – **4 places**;
- Advanced Sportscar Manufacturing – **1 place**;
- Off-highway Vehicle Engineering – **16 places**.

The allocation of places will be done based on the evaluation of the career by the Degree Program Board, according to the credits earned and the weighted average achieved in the exams of the I semester 2025/2026. The board will formulate the merit ranking on the basis of which the curriculum of suitable candidates will be modified.

8. COSTS, ALLOWANCES AND SUPPORT FOR CANDIDATES WITH DISABILITY

University fees are determined based on the ISEE 2026, which certifies the financial situation of the student's family. A NO TAX AREA exemption is available, but please refer to the Benefits Notice to be published soon (June/July 2026). Above the established threshold, university fees are calculated progressively.

Reductions in university fees will not be applied to students who do not submit their online application by the deadlines set or whose ISEE is higher than the maximum envisaged in the call for applications.

The request for the determination of the university contribution, together with that for scholarship, accommodation in university residences, catering services and other facilities, must be submitted online from the website www.er-go.it within the mandatory deadlines set by the Call Benefits, even before enrolling in the course of study. The Call will be published approximately from the beginning of July 2026. Students are invited to pay attention to the different deadlines.

Pursuant to Article 6, paragraph 4, of Legislative Decree No. 19/2026, the decision on the extraordinary appeal is adopted by decree of the President of the Council of State, in accordance with the opinion of the Council of State, in place of the previous decree of the President of the Republic, without prejudice to current legislation.
